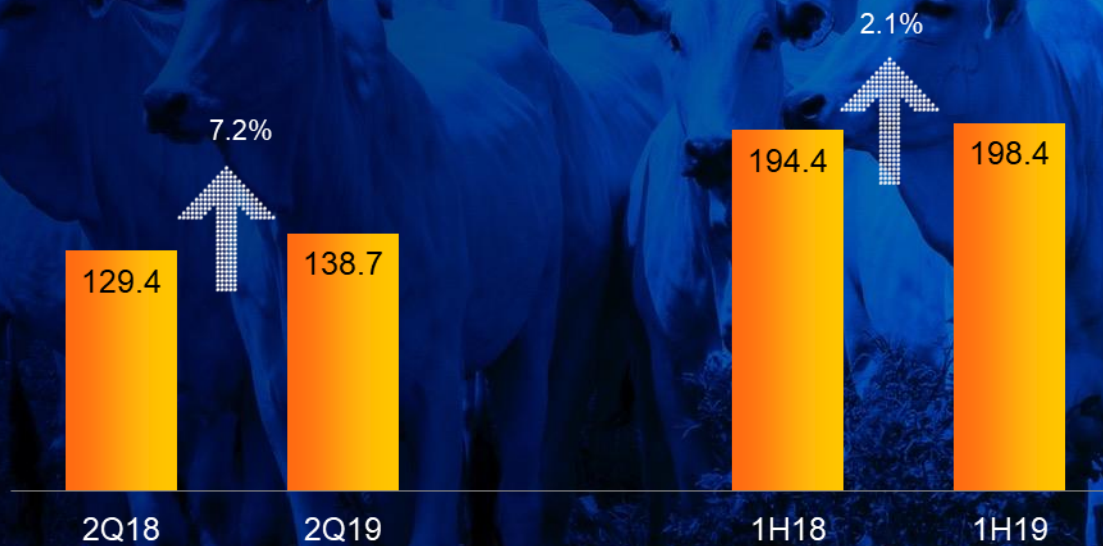

Production Animals

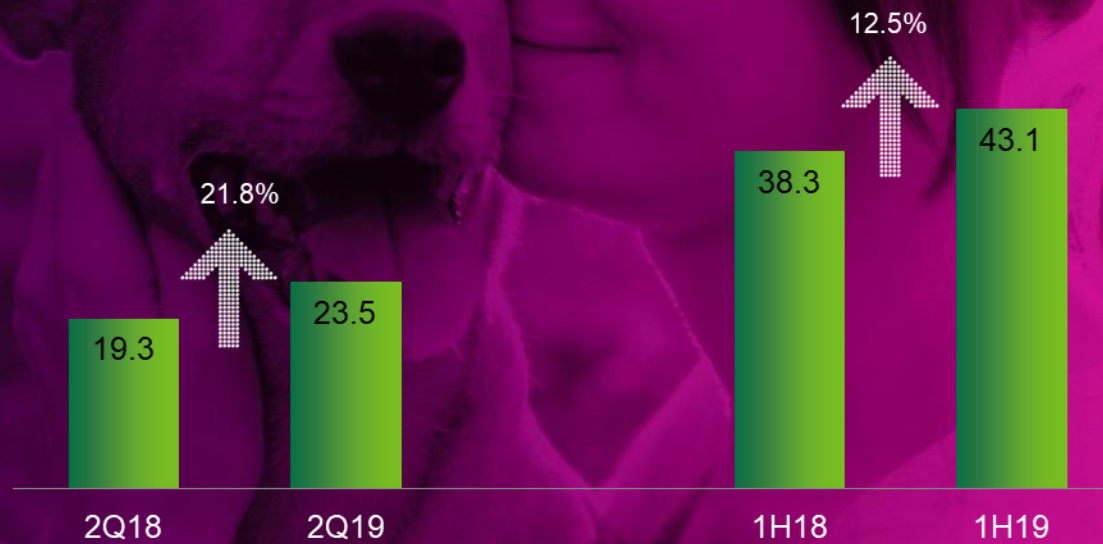

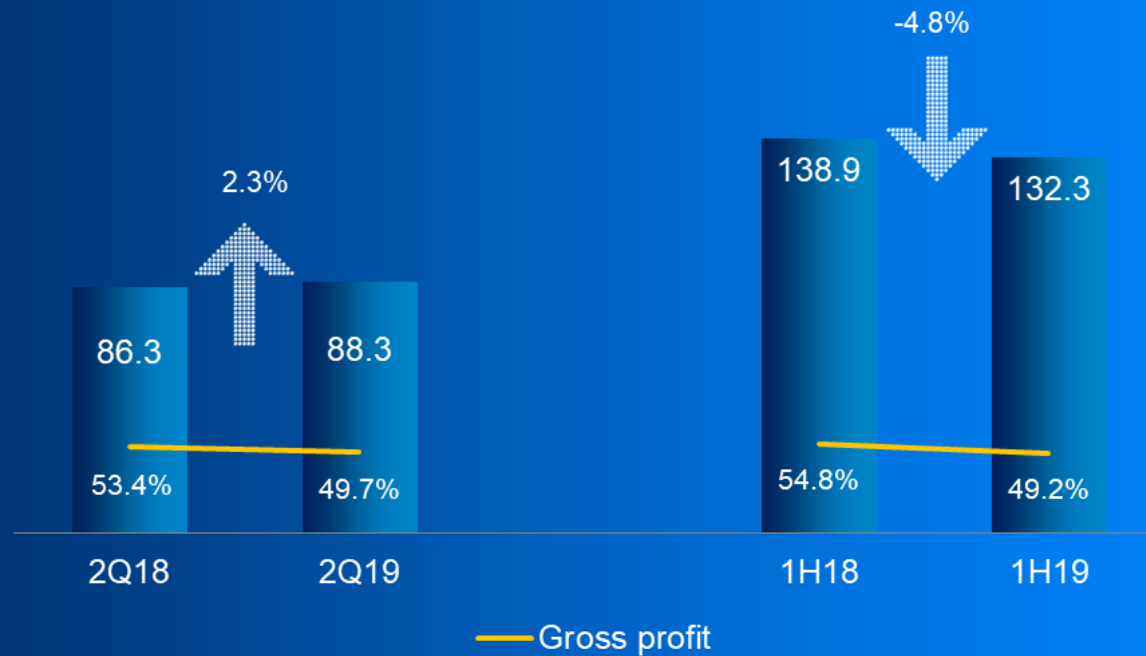

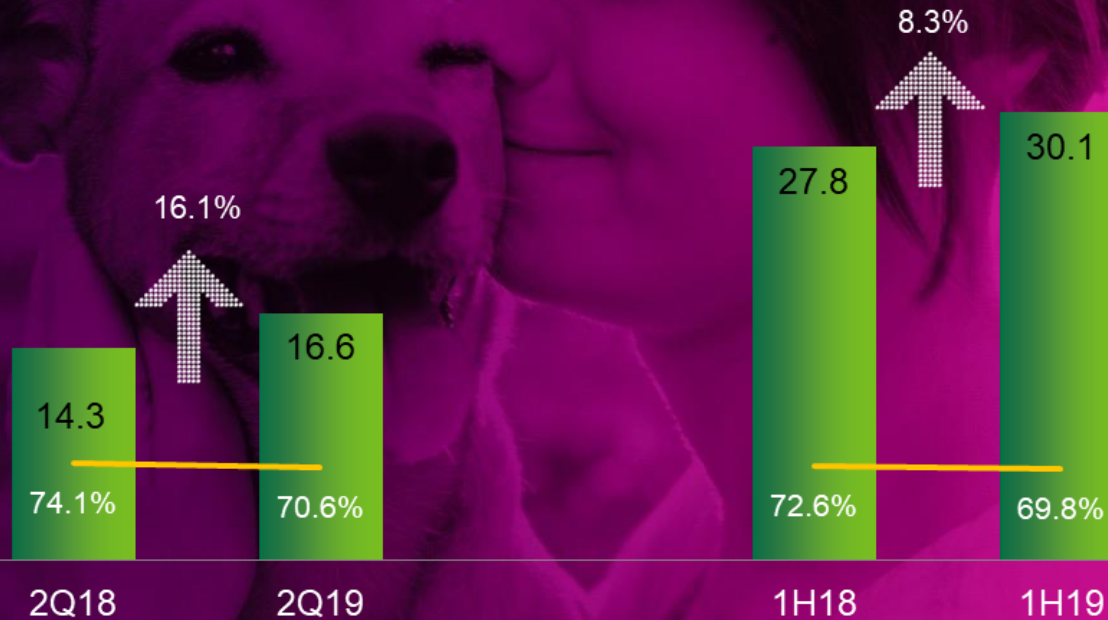

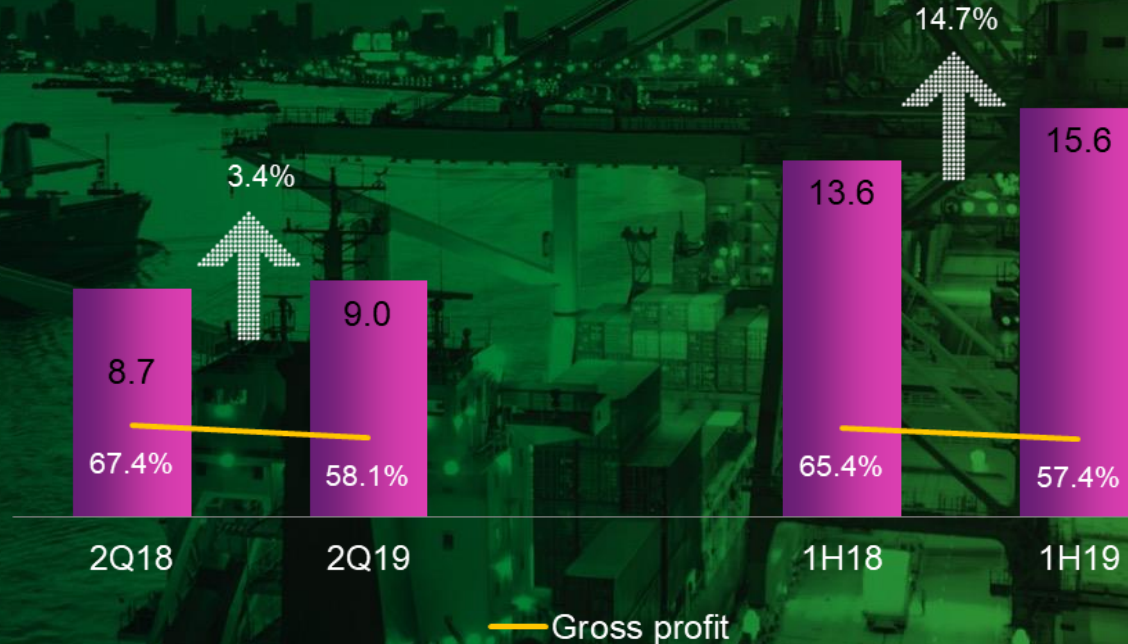

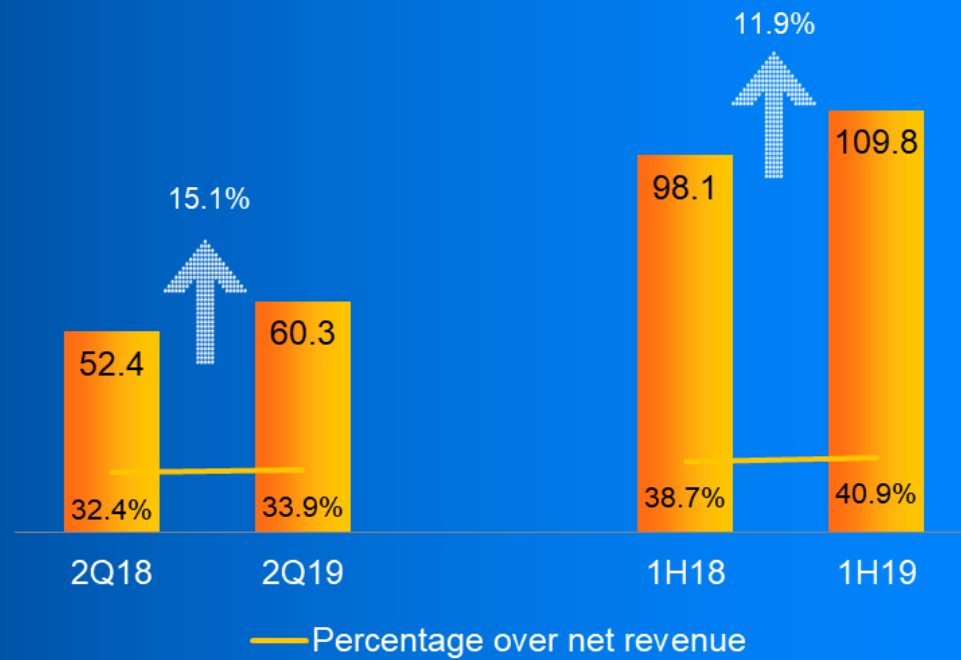

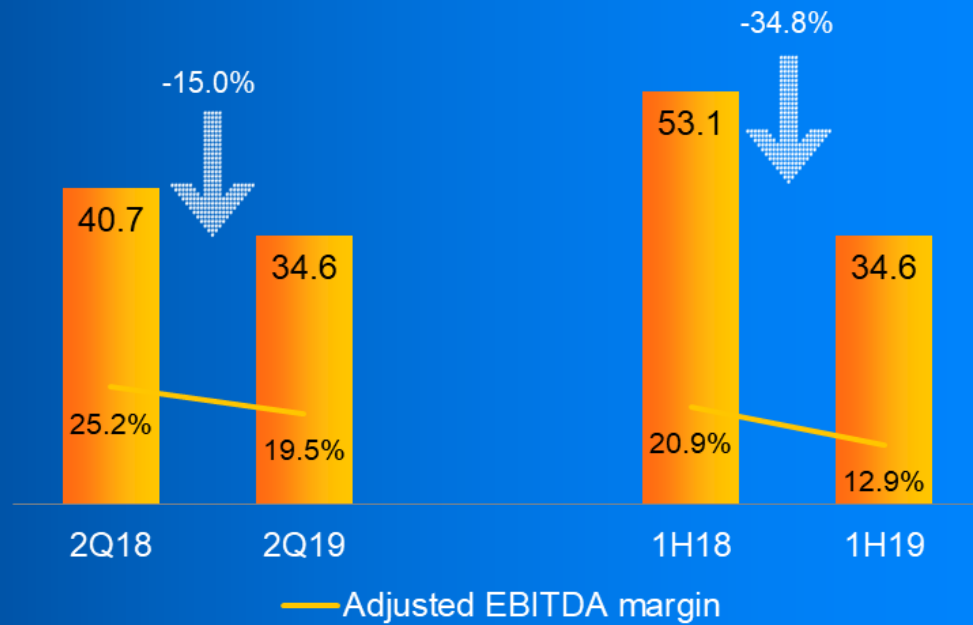

Adjusted EBITDA

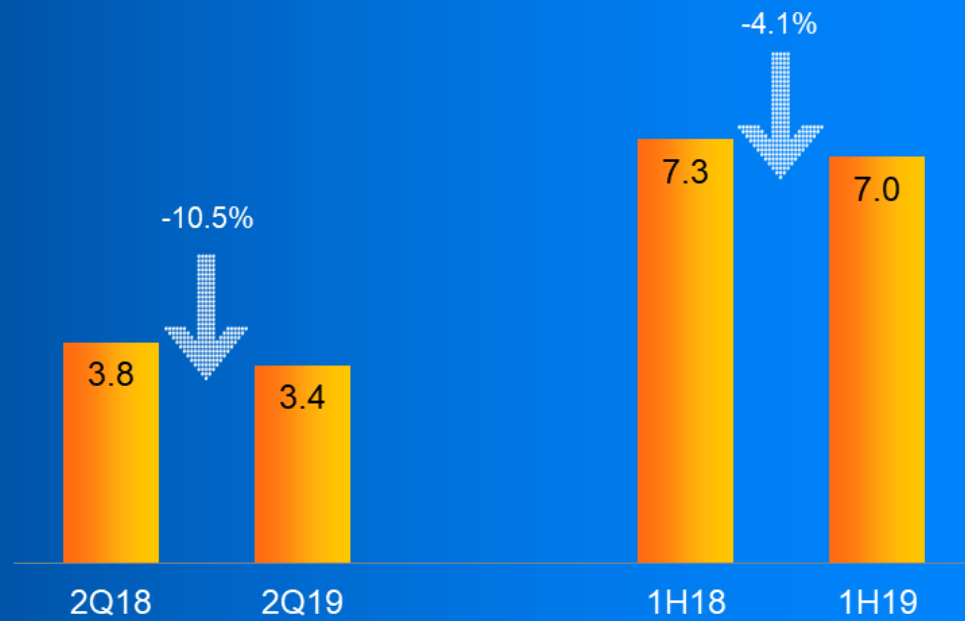

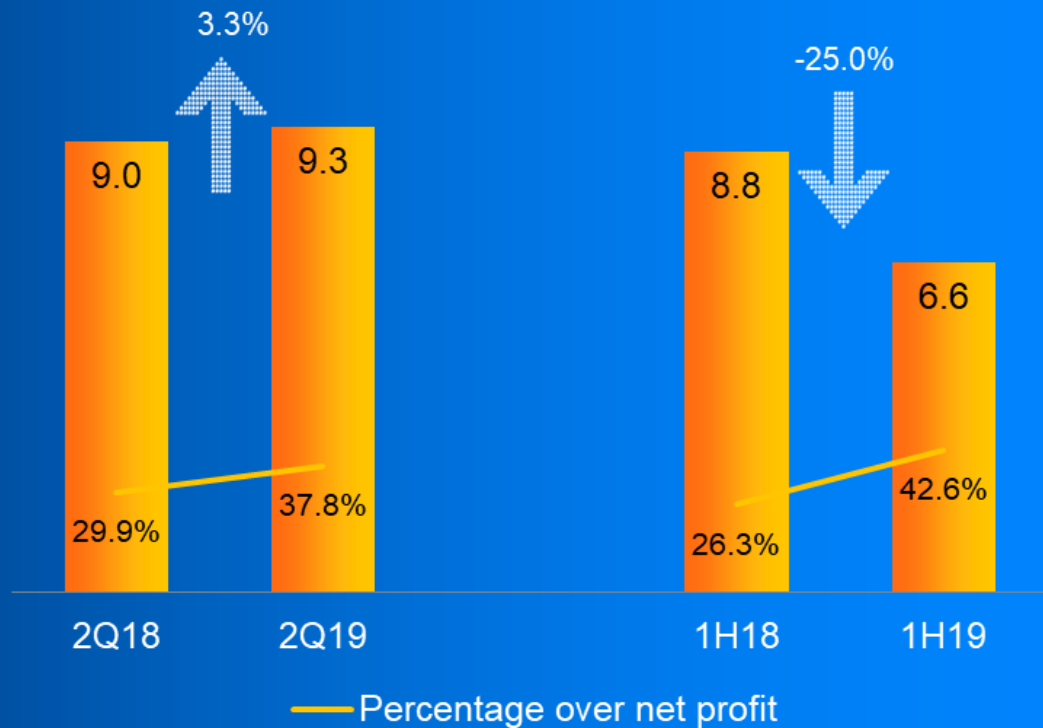

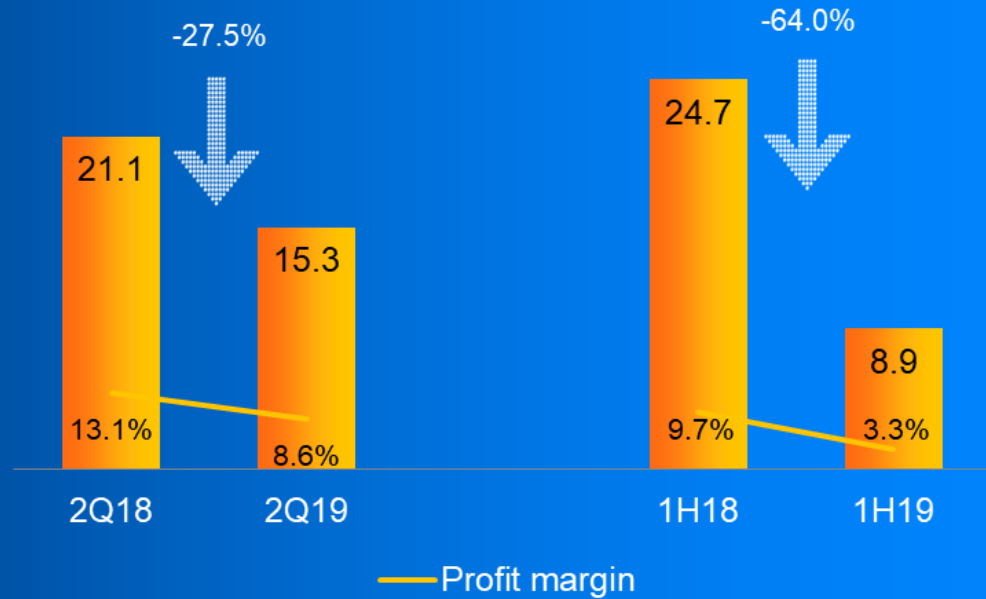

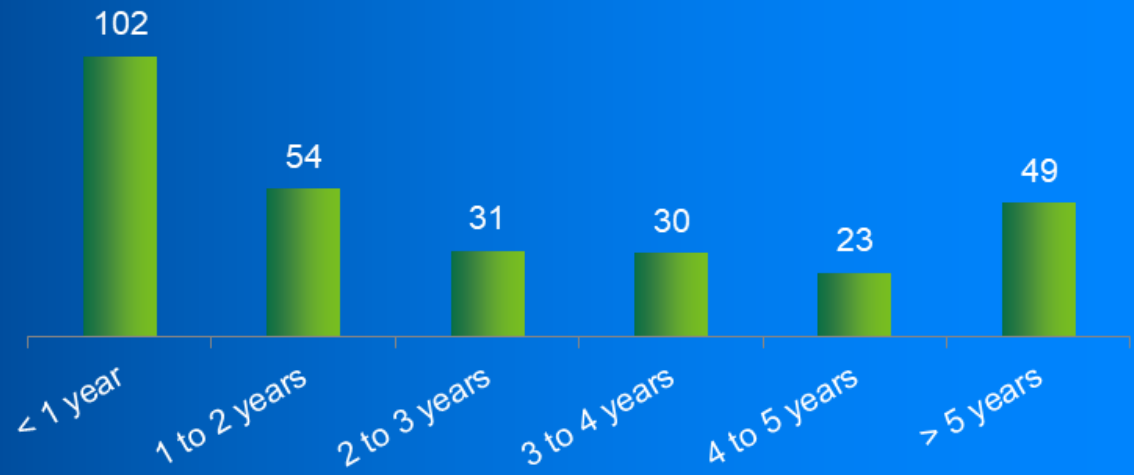

Debt Aging¹ (R\$ million)

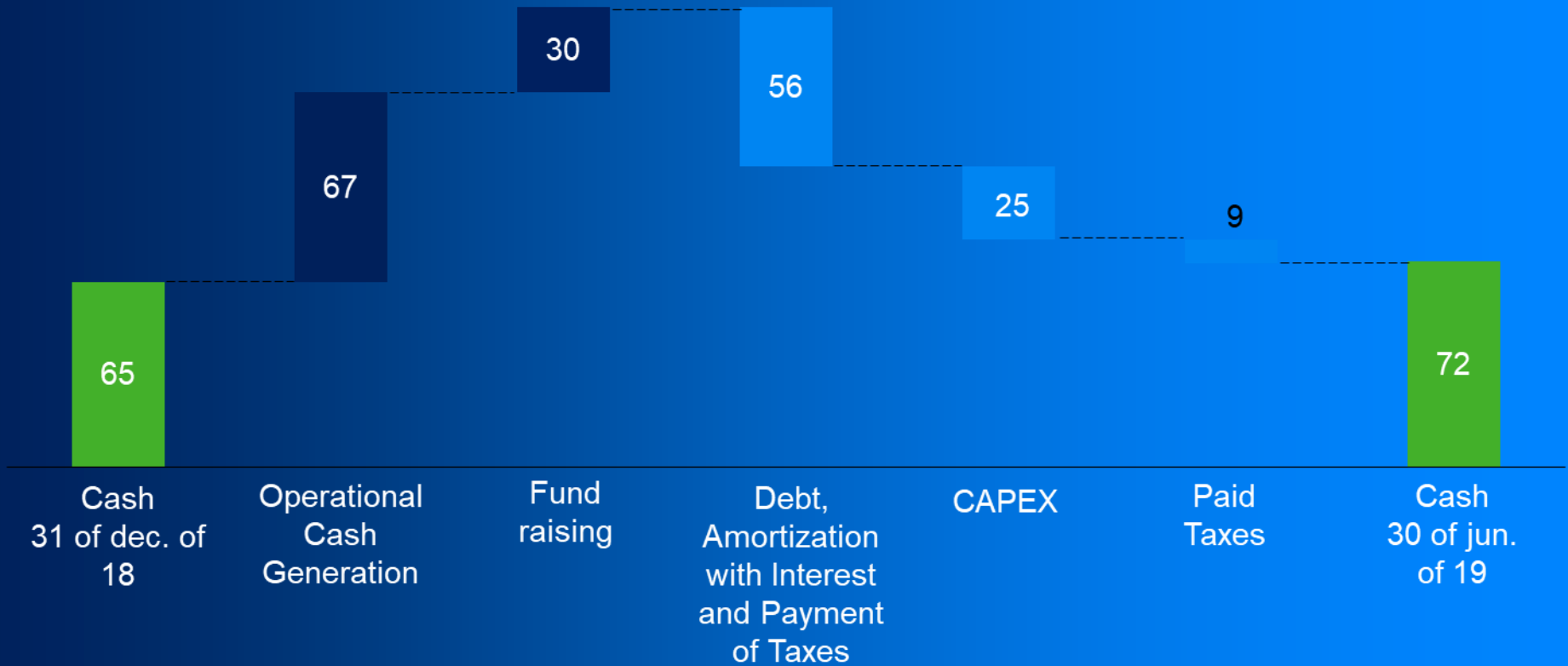

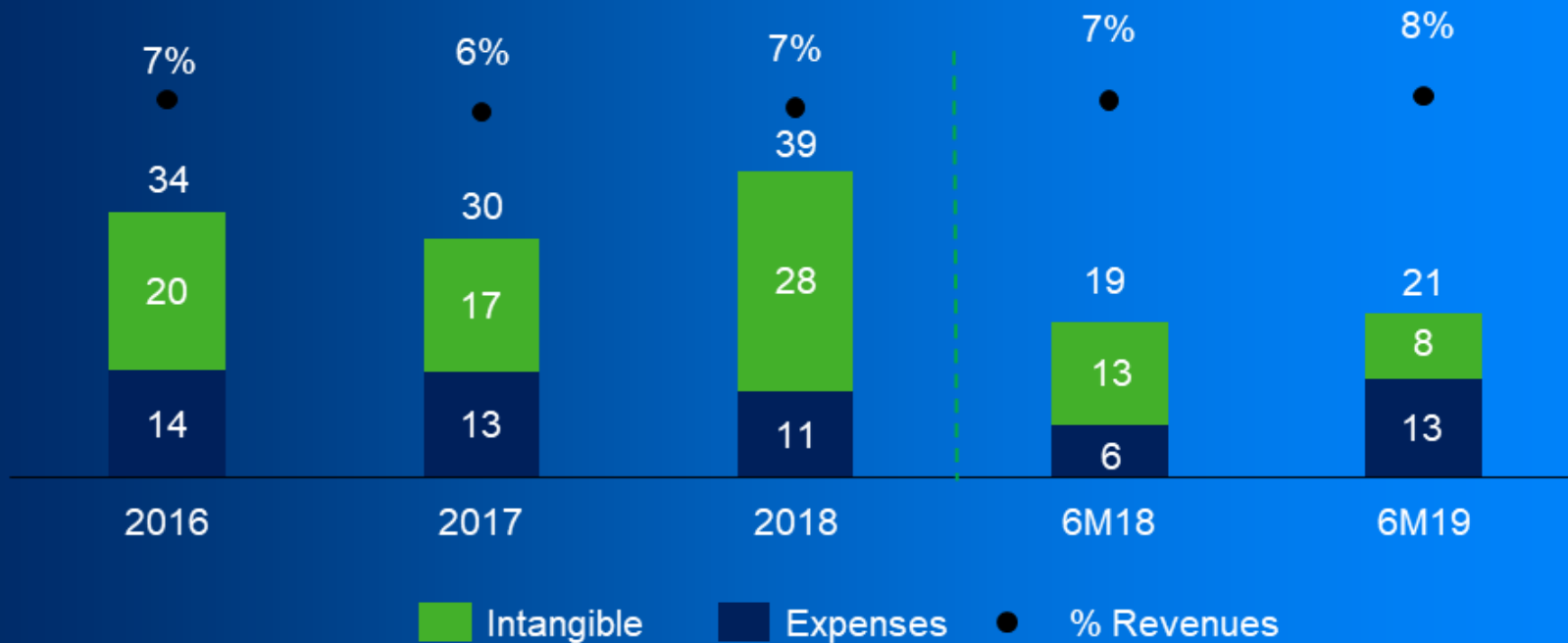
